

Membership Fee Regulations of the E-ISFA e.V.

With reference to § 9 of the Articles of Association, the following contribution regulations are drawn up with effect from 2023:

- Ordinary Members can only be natural persons whose clinical, scientific, technical and/or organizational activities focus on the field of apheresis. They pay an annual membership fee of 50 € (in words: fifty euros). Ordinary members have the right to nomite, vote and elect. The membership contains electronic access to the scientific journal (Therapeutic Apheresis and Dialysis) of ISFA and E-ISFA.
- 2. Associate Members can only be natural persons whose clinical, scientific, technical and/or organizational activities focus on the field of apheresis or who are in training / studying. They pay a reduced annual membership fee of 25 € (in words: twenty-five euros). Associated members have no voting rights. The membership does not include free access to the scientific journal (Therapeutic Apheresis and Dialysis) of ISFA and E-ISFA.
- **3.** Honorary Members and Members of Retirement Age are exempt from paying dues (on application). They have no proposal, voting or electoral rights.
- 4. Corporate Members can only be commercially active companies and organizations whose clinical, scientific, technical, and/or organizational activities are in the field of apheresis or related indication areas. The annual membership fee for Corporate Members depends on the level of membership as follows:
